technology, and are in the following fields: Electronic, Information,  
Communication, Optoelectronics, Biotechnology, Medical Science &  
Technology, Environmental Technology, Special Purpose Materials, Aerospace  
Technology, Precision Machinery, Nano, Superconductors, and other.

(Note 1):

The term “SME (Small and Medium Enterprise)” used by Small and Medium  
Enterprise Administration, Ministry of Economic Affairs means the enterprises  
which have legally completed company registration or commercial registration  
under the laws and conform to the following standards:

1. Manufacturing, construction, mining and quarry industries with a paid in capital of less than NT\$80 million.
2. Agriculture, forestry, fishery, animal husbandry, water, power and natural gas industries, commerce, transportation, warehousing and communications, financial and insurance, real estate, industrial and commercial services, social services and personal services with previous year turnover of less than NT\$100 million.

On account of the nature of business advisory services, each agency may consider the number of regular employees of the following specific business as the primary criterion for ascertaining small and medium enterprises, which are not subject to the provisions of the preceding paragraph:

1. The manufacturing, construction, mining and earth-rock industries that have fewer than 200 regular employees.
2. Agriculture, forestry, fishery, animal husbandry, water and gas, commerce, transportation, warehousing and communications, financial and insurance, industrial and commercial services, social services and personal services industries that have fewer than 50 regular employees.
