- 2. Party A shall provide the following services during the incubation service period.
  - (1) Providing general business/legal advisory from time to time.
  - (2) Free use of the book resources provided by Party A.
  - (3) Use of conference room or training room provided by Party A for 4 hours per month for free, subject to prior reservation.
  - (4) Providing information on relevant industry policies from time to time.
  - (5) Letting Party B participate in free speeches organized by Party A.
  - (6) Letting Party B participate in Party A's fee-based speech, or training course with 20% discount.
  - (7) Providing reference for applications for government programs.
- 3. Party A agrees to provide the space, located at \_\_\_\_\_Floor, Building No.: International Agriculture Building, Ding Qiao Zi Tou Section, S. Dist., Taichung City, a total of \_\_\_\_\_m², as the operating place for the use of research and development conducted by the employees of Party B from (date) (month) (year) to (date) (month) (year). - 4. In the event of either Party's breach hereof or dispute between the Parties, both Parties shall first seek settlement through negotiation. If the Parties need to file a lawsuit, they agree to accept the exclusive jurisdiction of the Taiwan Taichung District Court as the Court of first instance.
- 5. If Party B is in arrears or fails to fully pay the annual service fee during the period of settle-in, Party A may terminate the Agreement after reminding Party B of the payment within the time limit. Party B shall move out of the Center within one month; a certain amount shall be deducted from the deposit paid based on the Business Advisory Agreement for compensation of Party A's loss, and Party B shall not raise any objections.

- 6. Any unsettled issues relating hereto may be amended after mutual consent.
- 7. This Agreement shall be executed in duplicate, and each Party shall have one copy.
